The purpose of mediation Mediation is a voluntary process whereby each participant wants to find resolution and put an end to an ongoing dispute A qualified mediator assists the participants with attempting to achieve this purpose through a process of exploration, discussion and negotiation using their skills to help them agree positive outcomes
