What is History?

Much debate, research and commentary about class sizes in schools is limited because of an exclusive concern with class size and pupil academic attainment, and a neglect of classroom processes, which might help explain class size effects (or lack of them). "In this compilation, the authors analyze the feeling of empathy in the context of the constitution of empathetic bonds that mark human relations.
